## **Scholarship fund value increased to Rs. 2.92 crores this year**

**July 19, 2018, Mumbai:** The K.C. Mahindra Education Trust (KCMET) today announced that 82 candidates out of the 1066 applicants have received scholarships as a part of K. C. Mahindra Scholarships for Post Graduate Studies Abroad. Aimed at enabling higher education for the brightest and best students in India, this year it has marked a 45% increase in awardees, leading to an increase in the value of the scholarships awarded to Rs. 2.92 crores.
