The consortium will form a SPV (Special Purpose Vehicle) company to undertake the project, in which 70% equity will be held by the Company and 30% by BEBL. This SPV will benefit both companies; Mahindra Lifespaces will benefit from a strong execution capacity of BEBL while BEBL will benefit from the strong development & marketing capability of Mahindra Lifespaces.

Mr. Arun Nanda, Vice – Chairman, Mahindra Lifespace Developers said 'the bid won by the company, states the reputation that the company enjoys in delivering healthy living spaces to its customers along with the comfort of fair and transparent dealings backed by the trust and credibility of the Mahindra Group; this was one of the primary factors for us to win the bid'.

The residential project was primarily offered to various firms in order to meet the housing requirements of Multi-modal Internal Hub Airport (MIHAN) at Nagpur. The development of MIHAN Area will broadly comprise of development of Airport and Aircraft Maintenance Area, Special Economic Zone and support infrastructure. MADC has been appointed by the Government of Maharashtra as the Nodal Agency and also a Special Planning Authority for MIHAN.
