The week-long programme, which convened virtually this year from August 31- September 3, included a range of strategic discussions between USISPF's board members that includes 21 Fortune 500 CEOs and senior government officials from both countries.

The programme also hosted a public session with Mahindra Group's Deputy Managing Director, Dr. Anish Shah engaging in conversation with U.S. Deputy Under Secretary for International Trade, Joseph Semsar.
