("Covington") in Finland which in turn is a wholly owned subsidiary of MHRIL and subsidiary of the Company has been merged with Holiday Club Resorts Oy ("HCR"), incorporated in Finland, another subsidiary of Covington, MHRIL and consequently subsidiary of the Company, with effect from 28th February, 2023.

Pursuant to the above, HCRM has ceased to be a subsidiary of Covington, MHRIL and that of the Company with effect from 28th February, 2023.
