The L'Oeil d'Or documentary award, also known as The Golden Eye award, was created in 2015 by French-speaking authors' society LaScam in collaboration with the Cannes Film Festival.

All That Breathes, which recently had its premiere at the Cannes in the Special Screening segment, follows the lives of siblings Mohammad Saud and Nadeem Shehzad who, working out of their derelict basement in Wazirabad, a village in Delhi, rescue and treat injured birds, especially the Black Kites.

7 trekkers go missing in Rudraprayag

DEHRADUN: Seven trekkers have gone missing on the Pandav Shera trek route in Uttarakhand's Rudraprayag at a height of 4,500 metres, officials said. The State Disaster Response Force sent a high-altitude rescue team and a chopper to launch a search and rescue operation on Saturday evening. The 7 trekkers who are from Uttarakhand were making a documentary in the Pandav Shera trekking area. Lalita Negi. There was no contact with them after Friday evening, media in-charge SDRF said.

Caste census due to Nitish, not RJD: Upendra

PATNA: JD-U parliamentary board president Upendra Kushwaha on Saturday claimed the caste-based census was taking place in Bihar only due to chief minister Nitish Kumar. "If Nitish Kumar was not be the chief minister, caste-based census would never have happened in Bihar. Due to him, caste-based census is possible here. "The RJD may be taking credit for the caste-based census, but the truth is Nitish Kumar who had tabled the proposal in Bihar Legislature (assembly and legislative council) and it was supported by all parties," Kushwaha said.

Day 3: CBI questions Karti for 8 hours

NEW DELHI: The CBI questioned Lok Sabha MP Karti Chidambaram for eight hours for the third consecutive day on Saturday in its probe into the alleged Rs50-lakh bribery for issuance of visas to 263 Chinese workers involved in the construction of a Punjab-based power project in 2011, officials said. Karti arrived at CBI headquarters in Delhi at 9.30 am and was questioned till 6 pm, they said.

Rajya Sabha: Congress in a spot

RAIPUR: The decision of Chhattisgarh BJP not to contest for Rajya Sabha seats had cleared the road for Congress, but on the other hand, it also pushed the Congress into a spot. Under the leadership of Chief Minister Bhupesh Baghel, a perception was created that regional Chhattisgarhiya must be given preference in plum postings and appointments over outsiders. But in the context of Rajya Sabha MP seats, Congress seemed to adopt a different approach. —Avesh Mallick

Man uses power saw to kill wife, kids, self

CHENNAI: A man allegedly killed his wife and 2 children by slashing their necks with a power saw and then took his own life using the same tool, police said in Chennai on Saturday. Police found the bodies of the four persons lying in a pool of blood, with their throats slit, inside their house in Pozhichalur, near Pallavaram in the suburb of Chennai. Prakash, an IT employee from Pozhichalur had ordered an electric tree cutter online on May 19 and police said it suspected he killed his wife (Gayathri), son (Ritesh) and daughter (Nithyashree) using the same saw. "Prakash wrote a suicide note in English stating no one was responsible for the deaths but their own decision. Even though it is a suicide, we are looking at a murder angle," said Tambaram Commissioner of Police.

Punjabi writer Sultana Begum dead

PATIALA: Renowned Punjabi writer Sultana Begum died at a private hospital in Mohali on Saturday after a brief illness, sources said. Begum was born in 1949. After completing MA in Punjabi and Urdu, she did her PhD on Indian theatre. Begum also had a diploma in Persian language. She worked with the Punjab School Education Board, Mohali. Her book 'Shugufe' became popular. Begum, the first woman to write a literary satire in Punjabi language, was awarded the 'Professor Joga Singh' award and the 'Wari di Di' award by the Punjabi University.

Suicide pact: Man dies, wife, son in hosp

AMBALA: A man died while his wife and son are battling for life in a hospital after allegedly consuming some poison, police said on Saturday. Jaswinder, a resident of Naya Baans area in Ambala city consumed some poisonous substance along with his wife Kusum (58) and son Hitesh (34) on Friday evening. The neighbours took them to civil hospital at Ambala City from where they were referred to the Post Graduate Institute of Medical Education and Research in Chandigarh, police said. Jaswinder died during the treatment in PGIMER while the conditions of his wife and son are stated to be serious, police said. A suicide note was also recovered from the house in which Jaswinder said none should be held responsible. Jaswinder, who ran a grocery shop, had faced acute business losses during the Covid pandemic.

NC seeks FIR against BJP's Nupur

SRINAGAR: The National Conference on Saturday demanded stern action against BJP spokesperson Nupur Sharma over her alleged remarks on Prophet Muhammad during a television show. "The party expresses dismay over the 'blasphemous, offensive, and frighteningly hurtful' remarks of the BJP spokesperson against Prophet Muhammad during a debate on a national TV news channel," Salman Ali Sagar, provincial president, Youth National Conference (YNC) Kashmir, said in a statement. He termed Sharma's views unfounded, unsubstantiated and uncalled for in entirety.

BJP door-to-door drive for PM's Shimla rally

SHIMLA: The BJP is visiting door-to-door to invite people to attend Prime Minister's rally in Shimla. Himachal in-charge Avinash Rai Khanna, BJP State president Suresh Kashyap and Urban Development Minister Suresh Bhardwaj distributed invitation letters in Shimla's market. They invited the people of the city and businessmen to participate in the celebrations to be held in Shimla on May 31 to mark the completion of eight years of the Modi government.

Gyanvapi survey exposed reality: Sakshi

GONDA: BJP MP Sakshi Maharaj said the court-mandated videography survey of the Varanasi's Gyanvapi complex has "exposed" its reality, apparently referring to the claims that a Shivaling was found there. However, the Muslim side had denied the claim made by the Hindu side in the court, saying it was not a Shivaling but a fountain. The survey work was completed on May 16, the report of which was presented in the court on May 19. Indicating that there stood a Hindu temple in the past, the BJP MP said invaders changed its form and made a mosque. The reality of the Gyanvapi Masjid has been "exposed", he said.

JNU lauds alumna Geetanjali Shree

NEW DELHI: Jawaharlal Nehru University (JNU) on Saturday congratulated its alumna Geetanjali Shree, whose Hindi novel has become the first book in an Indian language to win the prestigious International Booker Prize. The New Delhi-based author won the prestigious award for 'Tomb of Sand', originally titled 'Ret Samadhi'. Set in north India, the story follows an 80-year-old woman in a tale the Booker judges dubbed a "joyous cacophony" and an "irresistible novel".

Fire at EV maker Ather Energy's premises

CHENNAI/NEW DELHI: As EV fires continue to make headlines in the country, a fire broke out at electric scooter manufacturer Ather Energy's experience centre in Chennai. The company said in a tweet that there has been a minor fire incident on its premises in Chennai. "While some property and scooters got affected, thankfully all employees are safe and things are under control. The experience centre will be operational shortly," the EV company said late on Friday. It, however, did not reveal what caused the fire incident. The company was awaiting a report from the local fire brigade officials.

Woman siphons 2L from dad's a/c, arrested

NEW DELHI: A 34-year-old woman was arrested for allegedly siphoning over Rs2 lakh from her retired father's pension account to get back her gold jewelry mortgaged with a finance company against a loan, police said on Saturday. While transferring money from her father's account using mobile banking between last November and March this year, the woman used to delete one time passwords and debit messages from his phone to avoid suspicion, they said.

The police began probing the case on the complaint from a 69-year-old retired employee of an electricity company in which he alleged that Rs 2.03 lakh was debited from his bank's pension account between November last year to March without his knowledge.

NCB nabs 8, seizes 35kg heroin

NEW DELHI: The Narcotics Control Bureau (NCB) on Saturday claimed to have unearthed a "major" pan-India heroin trafficking network with the arrest of eight people and seizure of about 35 kg of narcotics. The operation began on May 24 after the federal anti-drug agency first intercepted two women passengers who landed in Bengaluru from Zimbabwe and about 7 kg of heroin was seized from them..

DELHI TRANSPORT COMMISSIONER RIDES STATE BUS: Delhi Transport Commissioner Ashish Kundra rode a state bus to review issues being faced by commuters, a move which was lauded by CM Arvind Kejriwal and Transport Minister Kailash Gahlot. The commissioner's bus ride comes days after the Delhi government directed all group A and B officers of the DTC and the Transport Department to travel in a bus at least once a week and submit feedback on the conditions and staff behaviour.

Return of the 'prodigal' Chandna

The sports minister of Rajasthan, Ashok Chandna, who wanted to be free from a 'humiliating ministerial post' a day before, took a turn on Friday night after a brief meeting with chief minister Ashok Gehlot and said, "the CM is the guardian of Rajasthan Congress. Whatever decision he takes will be the right one." Chandna was denied meeting with CM Gehlot on Friday afternoon but finally managed to meet him late in the evening.

The meeting lasted 10 minutes and following which, Chandna tweeted, "it was a meaningful and lengthy discussion on all subjects with the honourable chief minister...he is the guardian of the Rajasthan Congress family, whatever decision he takes will be right. BJP (has to) set its house in order. Congress is united and mobilised for mission 2023."

It was almost opposite of what he had tweeted on Thursday night when he attacked the principal secretary of chief minister, Kuldeep Ranka and said he would be relieved of the ministerial duties since Ranka was behaving like a minister of all departments.

Connectivity with Myanmar, Bangladesh to lead huge change: EAM

External affairs minister S Jaishankar on Saturday said India was looking at road connectivity through Myanmar and sea connectivity through Bangladesh and this would see a huge change in the region.

Addressing a "NADI (River) Conclave 2022" in Guwahati, the EAM said 6 old cross border rail links between India and Bangladesh need to be restored.

There are 10 waterway protocol routes between India and Bangladesh. Nine new Border Haats (markets) between India and Bangladesh are being set up," Dr Jaishankar said, adding, "We are improving connectivity with Nepal and Bhutan."

Saying land connectivity through Myanmar and sea connectivity through Bangladesh would facilitate easy connectivity with Vietnam and Philippines. "The up-

coming connectivity not only would build the strong partnership with the ASEAN countries and Japan, but would actually make a difference to the Indo-Pacific Economic Framework. It is absolutely within our capability to overcome geographic bottleneck and rewrite history."

He said, "The coming together therefore of the Act East and the Neighbourhood First policies have an enormous reinforcing impact. And it is one that extends beyond the confines of South Asia."

Bangladesh foreign minister AK Abdul Momen said repatriation of displaced Myanmar nationals from his country is necessary for security and stability in Southeast Asia. Bangladesh is currently hosting more than 1.1 million "forcibly displaced Myanmar nationals" in Cox's Bazar and they want to return to their country, he said.

Is Iltija testing political waters?

SRINAGAR: PDP chief Mehbooba Mufti's daughter Iltija Mufti will hold a fortnightly interactive session with people, the party has announced, a move which many viewed as an exercise before she takes the political plunge. The party on Friday posted a 2-minute-video on its Twitter handle with the hashtag #AapKiBaatIltijaKeSaar.

"An air of despondency and despair has seeped through Kashmir. Everyday new blows are inflicted on us and it's important we #SpeakUp. The purpose of these fortnightly videos is to throw light on issues and decisions that affect our lives. #AapKiBaatIltijaKeSaar," the party tweeted.

In the video, Iltija, 34, says Jammu and Kashmir is passing through its worst phase in history. "An administration, a dispensation that is destitute of any vision has pushed our state into chaos. All the secular and democratic foundational values of

the country are being trampled upon and this is happening at a time when preparations are underway to turn the secular and democratic India into a Hindu rashtra," she said.

Its "disastrous consequences" on the country's only Muslim-majority state cannot be overlooked, she said. "Along with our basic rights, our freedom of expression has been throttled. An atmosphere of silence and fear has been created in J&K and the price of speaking up truth has to be borne by the people now," she said.

"In such terrible circumstances, it is imperative to speak up against the injustices and cruelty inflicted upon us. The aim is to start a conversation among us because even after stripping us of our rights and dignity, our voice cannot be snatched from us. J-K is filled with an air of despondency and helplessness," she said.

Jathedar's security cover restored but he refused: SGPC

CHANDIGARH: The Shromani Gurdwara Parbandhak Committee on Saturday claimed the Punjab government had restored the security cover of the Akal Takht Jathedar following its partial withdrawal but he refused to take it back.

However, till now there is no official reaction over the Sikh body's claim.

The Punjab Police on Saturday withdrew the security of 424 people, including Akal Takht Jathedar Giani Harpreet Singh, who had just a few days ago advised Sikhs to keep licensed weapons, drawing criticism from Chief Minister Bhagwant Mann.

Meanwhile, AAP leader Durgesh Pathak will contest the Rajinder Nagar assembly by-election next month, party leader Sanjay Singh said, daring Delhi BJP chief Adesh Gupta to join the fray and defeat the Arvind Kejriwal-led party's candidate.

Hemant Soren gets more time to appear before EC

NEW DELHI: Jharkhand CM Hemant Soren is learnt to have been given more time by the Election Commission to appear before in a case related to a mining lease.

Soren was asked to appear before the EC either in person or through his counsel on May 31. But he sought more time and is now learnt to have been asked to appear on June 14, sources aware of the development said.

Tripura bypoll dress rehearsal, get ready to oust BJP: Sarkar

Describing the upcoming by-poll to the 4 assembly seats in Tripura as "dress rehearsal", Leader of Opposition Manik Sarkar urged CPI(M) workers to cash in on "people's anger against the BJP-led government" ahead of next year's state elections.

Hitting out at the state government, Sarkar said it can't sustain its existence by changing the chief minister.

Unemployment at its peak; 65 lakh posts vacant: Varun Gandhi

NEW DELHI: Continuing to raise the issue of unemployment, BJP MP Varun Gandhi on Saturday said over 60 lakh sanctioned central and state government posts are vacant in various sectors when joblessness is at its highest level in three decades.

The MP from Pilibhit in UP tweeted a chart mentioning government jobs sector-wise.

"While crores of youth are frustrated and disappointed due to non-availability of recruitment, there are 60 lakh 'sanctioned posts' vacant in the country if 'government figures' are to be believed," Gandhi said.

These statistics are startling when unemployment is at its highest level in three decades, he said. Questioning where the budget has gone for the sanctioned posts, he said it is the right of youth to know about it.

You'll be voting CM, not just MLA: Yogi

DEHRADUN: As Champawat goes to bypoll on May 31, Uttar Pradesh CM Yogi Adityanath urged people in the assembly constituency to vote overwhelmingly in favour of Pushkar Singh Dhami, saying they were "electing a chief minister and not just an MLA".

BJP's Kailash Gehtori, who had won from this constituency in the February assembly polls, later vacated his seat to make way for Dhami after the two-term MLA lost from his stronghold Khatima.

1 dead, 3 cops hurt

PATNA: A head constable was killed and 3 constables were injured after a speeding truck rammed a police jeep in Bihar's Begusarai on Saturday. The accident occurred at NH-31 near zero mile in Bihat locality. The police team were patrolling the area when a speeding truck hit the police jeep from behind.
