With reference to the captioned subject, we would like to inform you that the Company has received an order from the Office of the Commercial Tax Officer, Saharanpur, Uttar Pradesh imposing a penalty u/s 129(3) of the CGST Act, 2017 amounting to Rs. 8,83,646/- in relation to the alleged E-way bill discrepancy in respect of goods transported from Vendor location in Gujarat to the Company's Auto Division plant at Haridwar, Uttarakhand.

Based on the Company's assessment, an appeal will be filed and the Company is hopeful of a favourable outcome at the appellate level and does not reasonably expect the said Order to have any material financial impact on the Company.
