With reference to the captioned subject, we would like to inform you that the Company has received an order from the Office of the Assistant Commissioner, Division-IV, CGST & Central Excise, Ahmedabad South imposing a penalty u/s 74 of CGST Act, 2017 amounting to Rs 56,04,246/- in relation to the two-wheeler business of Mahindra Two Wheelers Limited ('MTWL'), which was demerged from MTWL and has since been merged with the Company.

Based on the Company's assessment, an appeal will be filed and the Company is hopeful of a favourable outcome at the appellate level and does not reasonably expect the said Order to have any material financial impact on the Company.
