With reference to the captioned subject, we would like to inform you that the Company has received an order from the Deputy Commissioner, State Tax, Audit Wing, Indore-01, Madhya Pradesh imposing a penalty u/s 74 of CGST Act, 2017 amounting to Rs 4,11,50,120/- in relation to the two-wheeler business of Mahindra Two Wheelers Limited ('MTWL'), which was demerged from MTWL and has since been merged with the Company.

Based on the Company's assessment, an appeal will be filed and the Company is hopeful of a favourable outcome at the appellate level and does not reasonably expect the said Order to have any material financial impact on the Company.

The Order dated 28<sup>th</sup> December, 2023 has been received by the Company on 28<sup>th</sup> December, 2023 around 03:35 P.M.
