With reference to the captioned subject, we would like to inform you that the Company has received an order from the Deputy Commissioner, Hardwar- Sector 6, Haridwar, Uttarakhand imposing a penalty u/s 73 of the CGST Act, 2017 amounting to Rs. 7,49,542/- in relation to claim of the Input Tax Credit (ITC) against invoices pertaining to FY 2019-20 on which supplier has apparently not discharged GST liability.

Based on the Company's assessment, an appeal will be filed, and the Company is hopeful of a favourable outcome at the appellate level and does not reasonably expect the said Order to have any material financial impact on the Company.

The Order dated 24th August, 2024 has been received by the Company on 24th August, 2024 around 10:30 P.M.
