With reference to the captioned subject, we would like to inform you that the Company has received an Order from the Joint Commissioner, Medchal Commissionerate, Medchal GST Bhavan, Hyderabad imposing a penalty of Rs. 9,49,28,881/- under Section 74 of the CGST Act, 2017 and a penalty of Rs. 1,25,000/- under Section 125 of CGST Act, 2017 against the Company, by disputing tax rates applicable on goods and services supplied by the Company.

Based on the Company's assessment, an appeal will be filed, and the Company is hopeful of a favourable outcome at the appellate level and does not reasonably expect the said Order to have any material financial impact on the Company.

The Order dated 23rd December, 2024, has been received by the Company on 24th December, 2024 at around 3:15 P.M.
