## Mahindra's Auto Sector registers overall growth of 11% in FY-19

Sells 62,952 vehicles during March 2019

**Mumbai, April 1, 2019:** Mahindra & Mahindra Ltd. (M&M Ltd.), a part of the USD 20.7 billion Mahindra Group, today announced its auto sales performance for the financial year ended March 31, 2019, which stood at **6,08,596** vehicles, compared to **5,49,153** vehicles during FY-18, registering a growth of 11%. For the month of March 2019 the company sold **62,952** vehicles, a marginal growth over March 2018.

The company's domestic sales touched **59,012** vehicles during March 2019, as against **58,652** vehicles in March 2018.

The Passenger Vehicles segment (which includes UVs, Cars and Vans) sold **27,646** vehicles in March 2019, registering a growth of 4%.

In the Commercial Vehicles segment, the company sold **24,423** vehicles in March 2019, as against **25,495** vehicles in March 2018.

In the Medium and Heavy Commercial Vehicles segment, M&M sold **917** vehicles for the month. Exports for March 2019 stood at **3,940** vehicles, a growth of 15%.

Commenting on the performance, **Rajan Wadhera, President, Automotive Sector, M&M Ltd.** said, "We have closed FY-19 with robust double digit growth of 11% at an overall level, despite strong headwinds faced by the Indian automotive industry this year. This growth has been supported by our three new product launches, which have been well received in the market. The commercial vehicles segment and exports have also posted strong growth rates of 15% and 37% respectively."

# Mahindra's Farm Equipment Sector Sells 3,30,436 Units during FY-19

**Mumbai, April 1, 2019:** Mahindra & Mahindra Ltd.'s Farm Equipment Sector (FES), a part of the USD 20.7 billion Mahindra Group, today announced its tractor sales numbers for March 2019 and the financial year ended March 31, 2019.

Domestic sales in March 2019 were at **18,446** units, as against **27,155** units during March 2018. Total tractor sales (domestic + exports) during March 2019 were at **19,688** units, as against **28,477** units for the same period last year. Exports for the month stood at **1,242** units.

For the financial year ended March 31, 2019 (F-19), the total tractor sales (domestic + exports) were at **3,30,436** units as against **3,19,623** units in F-18. The domestic sales in F-19 were at **3,16,742** units, as against **3,04,019** units for the same period last year.

Commenting on the performance, Rajesh Jejurikar, President - Farm Equipment Sector, Mahindra & Mahindra Ltd. said, "We are happy to end F-19 with total sales of 3,30,436 tractors for Mahindra's Farm Equipment Sector. However, the month of March was slow in the domestic market due to postponement of festive season to April and lower Rabi sowing than expected. We hope that the Government's focus on rural development, a good forecast for horticulture production and an increase in the MSP will positively impact demand for tractors, going forward."
