# Mahindra Auto Sector sells 35,187 vehicles in December

## **Registers 5% growth in Utility Vehicles**

**Mumbai**, **January 1**, **2021**: Mahindra & Mahindra Ltd. (M&M Ltd.), a part of the USD 19.4 billion Mahindra Group, today announced that its overall auto sales (passenger vehicles+ commercial vehicles+ exports) for the month of December 2020 stood at **35,187** vehicles, compared to **39,230** in December 2019.

In the Utility Vehicles segment, Mahindra sold **16,050** vehicles in December 2020, compared to **15,225** vehicles in December 2019, registering a growth of 5%. The Passenger Vehicles segment (which includes UVs, Cars and Vans) sold **16,182** vehicles in December 2020, a growth of 3% over same period last year.

Demand continues to remain strong even after the festive season and as we get into the new year."

# Mahindra's Farm Equipment Sector Sells 21,173 Units in India during December 2020

Registers a growth of 23%
